WELCOME TO THE SPRING 2024 EDITION

Spring is here and with it some very wet weather. We have been working with the Local Lead Flood Authority, the District and County Councillors and members of the public to understand why Long Stratton is prone to flooding and what we can do to mitigate further flooding. This is a work in progress and I will continue to update you all as more information comes to light.

The bypass work has commenced and has seen 4 roads been permanently closed for the duration of the build, Hall Lane, Parkers Lane, Edges Lane and Church Lane. They will be inaccessible to all including walkers. The anticipation is that the bypass will be delivered by summer 2025 however this will be reliant on weather conditions and as such we are hoping for a dry summer to allow the works to progress. There will be information in the Town Council Pavilion which will be updated regularly with the progress the bypass has made.

Diane Woodham has made the difficult decision to step down, she has been a Councillor for many years and the Town Council would like to thank her for her service to Long Stratton. We do currently have a vacancy at the Town Council, if you are interested please come to the next Town Council meeting on May 13th at 7pm in the Pavilion.

We would like to welcome Katrina Thompson to the Council and we look forward to working together.

Finally the summer event will be held on the 6th July on the playing field, the team are working hard to ensure that there is plenty to see, play and do and we hope to see as many of you there as possible.

Anastasia, Long Stratton's new Youth Worker has been extremely busy over the last few months meeting up with many people, groups, schools, businesses and the local Police.

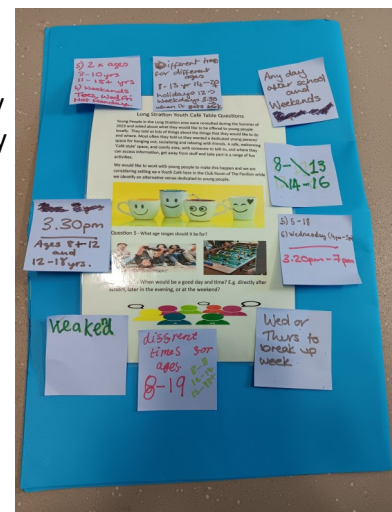
February Drop-In Youth Café Session

It was great to meet some young people, parents and other interested adults who popped in to say hello at the 'Meet the Youth Workers' event at the end of February at The Pavilion in Long Stratton during the half-term break. As the weather was very wet we decided to stay indoors where it was warm and dry and offer a taster of what we could offer as a drop-in 'Youth Café'. There was an opportunity to enjoy some creative activities, including badge making and bead jewellery, whilst chatting and enjoying a fully loaded hot chocolate and snacks. We also asked young people attending for their views on:

What they'd like to be offered and what equipment was needed?

What age ranges it should be offered to and when?



Easter Break Drop-In Youth Café Sessions

37 young people attended the drop-in Youth Café sessions during the Easter break across three sessions open to young people 8-11 years on Tuesday 9th April, followed by two sessions back to back for 11-16 years and then 16+ years on Wednesday 10th April. Activities included making chocolate nest cakes, decorating (and eating) eggs, playing UNO, pool, table-tennis and giant jenga; although some young people just wanted to come, hang out with their friends and enjoy the drinks and snacks on offer. Long Stratton Town Council received 50% Parish Partnership Funding and were able to purchase an additional SAM2 machine (Speed Awareness Monitoring).

This additional machine will be used in conjunction with our other SAM2 device to monitor vehicles using back roads, roads joining the A140 and near to the schools. This is to help reduce anti-social driving and speeding in Long Stratton as requested by residents who contact us often regarding dangerous stretches of road with speeding motorists.



This information will be used to inform the Norfolk Constabulary regularly so that further support / action can be sought. Regular reports are published on the website.

2024/2025 Annual Precept



As the Council tax bills have been received, I wanted to take this opportunity to break down the increases for you. No one, including the Councillors who made the decision, want to pay more Council tax, however at times, in order to deliver essential services this cannot be helped. The Councillors are all volunteers so there is no financial gain to themselves in increasing the Precept, in fact they will also have to pay the additional rate the same as the rest of the Long Stratton community.

The budget for the coming year was discussed at length at multiple meetings before the final amount was officially agreed.

The first step is to receive the tax base from South Norfolk District Council. This is the amount of Council Tax Band D properties within Long Stratton. In 2023-24 the tax base was 1432 properties. The amount of money requested from South Norfolk District Council (known as Precept) was £213,942 which is then divided between the 1432 properties giving a Council Tax requirement of £149.40.

In 2024-25 the Council Tax Band D properties was reduced to 1420 which meant that by keeping the Precept the same the Council was already seeing an increase in levy on taxpayers increase to £150.66.

The second step is to establish which contractors and regular suppliers were increasing their rates. All businesses and individuals providing a service to Long Stratton Town Council are facing the same challenges the community are, all increased their prices. For the services that are unknown to the Council, the Council's Finance Officer used an average of the known rises.

Third step is to calculate the income that the Council receives, this income primarily comes from hiring the Council Pavilion and is based on the hires from 2023-24. This is not guaranteed income as hirers can find new venues and therefore it has to be treated with caution when calculating the budget.

Fourth step is to calculate the difference between the income and expenditure anticipated based on the second and third step.

For Long Stratton the expenditure was £278,169.78, the income anticipated was £26,281.78 leaving a difference of £251,888. This would have seen a rise in Precept of 15% which was not acceptable for the Council. The Council went through the budget and examined each line of expenditure for further cuts that can be made.

As the budget is determined by January, 3 months before the new financial year starts. It was undetermined as to whether the full budget for 2023/24 is used, using budget control reports, the Council became aware that the full budget is unlikely to be fully used. The expected surplus was then used to support the budget for 2024/25 meaning that the new difference required was £239,888.

Ear Marked Reserves is monies held for future projects and savings, it can include grants received. In 2020 Long Stratton Town Council received a grant from South Norfolk District Council for ongoing maintenance of the Swan Lane toilets which equates to £9,900 pa. With the anticipation of new houses in the coming years which will lead to the Band D property tax base increasing, the Council agreed to use 2025/26 allocation of £9,900 to reduce the difference further meaning that the new difference is £229,988 8.4% increase.

What does this mean for you?

The increase in percentage terms is 8.4%, but in reality it is an increase of, per Band D property from £149.40 to £161.96.

(if you are not on Band D Council Tax, this figure will go down if you are on a Band A-C and will go higher if you are above Band D).

This increase is £12.56 a year, only £1.05 a month.

Some of the projects the budget has completed for the residents of the community this year.

- Delivery of new play area (in conjunction with Ear Marked Reserves and grants)
- Delivery of a youth shelter
- Delivery of The Kings Coronation event
- Supporting the Easter event with Easter eggs for the children
- Employing a Youth Worker
- Running a warm hub café

The Council are looking forward to potentially delivering additional projects that will benefit the Community, this includes; providing a thermal imaging camera to assist parishioners in how to minimise their energy bills, signposting to grants available for assistance and a Border Hopper service for supermarket shopping. We would welcome more ideas of how we can assist the community.

What your Town Council does

Playing fields

We look after the MUGA, skate park, play area and trim trail, CCTV, BMX track, litter picking, grass and hedge cutting and any other matter relating to the playing field.



Pavilion

On going maintenance, pavilion bookings, out of hours service for hirers, CCTV, public toilets, defibrillator.

Street furniture and facilities

Benches, notice boards, bus shelters, Swan Lane public toilets, defibrillators, SAM2 (x2), Town sign, Manor Road telephone box, Town plain, open space by footpath 12, dog bins and litter bins (emptied by South Norfolk District Council), grit bins (filled by Norfolk County Council), 126 streetlights (Norfolk County Council are responsible for the remaining street lights) Christmas motifs, Christmas trees.



Community Engagement

Summer event, supporting a Christmas event, Neighbourhood Plan, signposting and assisting residents with varied queries, organising Remembrance Day road closure and apparel, youth outreach work and events, providing grants for the community, website, social media, quarterly newsletter and working closely with third parties such as the Police to tackle anti-social behaviour.

The Town Council has the following committees:

Planning and Highways

The committee meets to discuss and decide on supporting or objecting to planning applications based on material considerations as a statutory consultee. The final decision lays with South Norfolk District Council.

Events

The committee meets to discuss upcoming events and community engagement.

Leisure and Pavilion

The committee meets to discuss the maintenance of the playing field, enhancements to public open space that the Council has control of and all matters relating to the pavilion.

Finance and Policy Management

The committee meets to discuss all budgetary matters and reviews the Council's policies.

Staffing Committee

The committee meets to discuss all matters HR.

Action Group

The committee meets to discuss how to enhance Long Stratton as a place to live, how to support residents and to discuss securing funding to support this. All items on the Action Plan has been derived from parishioners from the Neighbourhood Plan. Actions can be added to the plan at any time as and when a need is identified.



The Committees meet a minimum of 4 times a year except for staffing that meet when a need arises. In addition to this the Full Council meets every second Monday of the month at 7pm in the Town Council Pavilion apart from August.

Community room for hire
