## The Norfolk County Council (Long Stratton, C889 Ipswich Road, C889 Norwich Road and C889 Parkers Lane) (30 mph Speed Limit Zone) Order 2025

The Norfolk County Council in exercise of its powers under Section 84 of the Road Traffic Regulation Act 1984 (the "Act"), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:

- 1. This Order may be cited as the Norfolk County Council (Long Stratton, C889 Ipswich Road, C889 Norwich Road and C889 Parkers Lane) (30 mph Speed Limit Zone) Order 2025 and shall come into effect on the 11<sup>th</sup> day of August 2025.
- 2. No person shall cause or permit any motor vehicle to proceed along the lengths of the roads specified in the Schedule to this Order at a speed exceeding 30 miles per hour.
- 3. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those Regulations.
- 4. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of roads specified in the Schedule to this Order, that provision of this Order shall prevail.

C889 Norwich Road (formally A140 Norwich Road)	-	From a point 31 metres south of the northern kerb line of the southernmost splitter island of the Church Lane Roundabout to a point 73 metres north of the centreline of its junction with U71007 St Michaels Road
C889 Parkers Lane	-	From a point 48 metres northwest of the eastern kerb line of the westernmost splitter island of the Parkers Lane Roundabout to its forked end which joins C889 Ipswich Road at points:
