#### 1. To consider apologies for absence

Councillors Eddie Earp for annual leave and K Worsley for medical reasons.

#### 2. To receive disclosures of interest and dispensations

Councillor Bambridge declared an interest in item 3.

#### 3. To discuss and decide on requirements of LSFC for resolution or delegation to full Council.

The Committee reviewed the storage containers and the available storage available in the pavilion. It was **resolved** to empty out one of the Councils containers for the use of LSFC. The decision of charging a rent for the container was deferred to full council.

#### 4. To discuss and decide on picnic benches for outside the pavilion

Following a lengthy discussion; it was **resolved** with 4 votes to 2 not to purchase picnic benches at this time. The Committee agreed to move the picnic bench from the petanque area which is unused to the front of the pavilion to see how the bench was used before any further decisions are made.

#### 5. To discuss and decide on noticeboards for

a. Pavilion

It was **resolved** to purchase a noticeboard for outside the pavilion for Council notices.

b. Entrance to the playing fields

It was agreed to recommend to Council purchasing 3 noticeboards for the entrance to the playing fields to Council, the Clerk to source quotes.

### 6. To review the condition of the playing field and playground and recommend any additional work requirements.

An inspection of the playing field and playground was undertaken, the petanque area had been vandalised and it was **resolved** to remove the wooden trim which was rotten. The playground was inspected and noted that all the equipment had been painted and was looking good. The fencing to the entrance was reviewed the Committee asked if the final 3 panels could be reduced to 2 metres rather than 3. The Clerk to enquire.
