## QUEEN'S JUBILEE EVENT, JUNE 4TH 2022



## Queens Jubilee, Sat 4th July 2022

What a day! It was an early start for Councillors and Officers alike, taking delivery of the stage and starting to put up the gazebos. The weather was overcast in the morning and the sun came out to shine in the afternoon. The Council had advertised through social media, posters and the Sexton's Wheel for stall holders and performers and we contacted all community groups, local schools and performers in the near area such as ARTS.

Sadly we had 4 stalls cancel, 3 of which were within 24 hours of the event and all bar 1 live band cancel, the last artist was with less than 4 days notice.

We were grateful for Tribal Fitness and Norwich Devils (American Football) who gave some amazing performances in the afternoon. And LSFC who provided a Youth tournament in the morning.

The council's objective for the event was to provide an event that is as cost friendly to the public purse. This was in recognition of the additional pressure households are facing with the cost-of-living crisis and especially the cost of oil in Long Stratton.

As such, the Council decided to put on a number of free games for
children and their family and friends could enjoy. We had giant jenga, table tennis, 2 lots of connect four, whack a rat and giant snakes and ladders. The space hoppers were thoroughly enjoyed by the children.

In addition to the games that were available all day, the Council ran some community games - egg and spoon races, obstacle races, skipping races and space hopper races. We were overwhelmed with the enthusiasm of the children who were so keen to participate. It was lovely to see so many happy faces. The games concluded with a tug of war and again it was great to see so many people willing to participate.

The evening concluded with Oli's band 'One Knight Only' who played for over 2 hours and rocked us out before the evening concluded at around 9.30. The big clear up was then underway and Councillors and officers left the site between 11-11.30pm.

For the Council's first big summer event, with the resource we had available to us we believe the day went very well and I would like to thank East Coast Truckers for providing the stage, Top 2 Bottom cleaning services who sponsored the event for $£ 250$, the East of England Co-op who offered $3 £ 10$ vouchers for the Tombola and El Greco and Pizzaria who donated 2 $£ 20$ vouchers for the tombola.

The Council would also like to thank Jess, Tom and Emma - Council officers who worked tirelessly to put the event on. Tom built the props and prepared the field and play equipment, Emma designed and painted the amazing picture board, while Jess navigated the difficulties of booking stalls, sourcing bands that were prepared to play for free and managing the challenges of late minute cancellations as well as competing with the rest of the country in celebrating the Jubilee. The Council would also like to thank all Councillors and volunteers that worked hard throughout the day.

There are of course, lessons to be learnt, no one event can be perfect! For next year, it is our intention to have more stalls and more live music although cancellations are out of our control! We would love all community groups to be involved, please get in touch with us if you are interested.

You will have heard recently that all planning applications where the water course feeds into the broads have come to a standstill due to an issue around the subject of nutrient neutrality.

There have been concerns regarding the impact of phosphorus and nitrogen on the water quality from new developments.

In addition to this, The Conservation of Species and Habitats Regulations 2017 require local planning authorities to ensure that new development does not cause adverse impacts to the integrity of protected habitats.

New developments are required to provide evidence for how they intend to mitigate the impact of wastewater from new homebuilding.

The planning authorities are working hard to get a mitigation strategy in place as they are waiting on guidance from DEFRA.

What does that mean for the bypass and 1800 home application? The Highways department are still within the funding window provided by Department for Transport (DfT) for the next phase of the bypass and as such although there may be a small delay, we have been reassured that it will not prevent it being delivered.

## PLAY GROUND UPDATES



As reported in the last newsletter, the Council are looking for funding to replace the older pieces of play equipment and renovate the pieces of equipment that are going to stay.

I am pleased to confirm that the renovation of equipment that is staying has now been done. Tom, grinded down the arch, the elephant, 3 sets of swings and both ladders to the bare metal and these have now all been primed and painted in vibrant colours to make the play equipment look fresh.

The quest for funding continues and at the time of writing we have applied for 2 grants for $£ 10,000$ and $£ 15,000$ and are in the process of applying for a further $£ 5,000$. Combined with the Council's ear marked reserves should see some but not all of the equipment being replaced. It is the Council's intention to replace all the equipment needed eventually and to put in a new trim trail near where the MUGA is.

The Council would like to thank the volunteers that helped to paint the equipment to get it ready for the Jubilee and all users of the play equipment for your patience whilst the maintenance work was carried out.

As soon as we are in a position to install new equipment as chosen by the children and consultation we will let you know! Watch this space!



Do you know that the Council received a grant of $£ 9,900$ pa for the next 5 years

Do you know that since 1st April 2022 the toilets have cost the Council $£ 4566.72$ meaning the expected annual cost will be $£ 18,266.88$ and that is only if there is no more vandalism or severe blockages.

Do you know that since 1st April 2022 the toilets have been unblocked at least 12 times with Dyno-rod being called once.

Do you know there is vandalism and anti social behaviour that occurs weekly in the public toilets that needs to be put right.

Do you know that the Council relies on volunteers to help lock and unlock the toilets daily?

Public toilets are a great community asset but please help us to keep them a great community asset.
